

MEMORANDUM OF AGREEMENT

Vanadzor School # 20, based in Vanadzor, Republic of Armenia, and the Center for International Understanding, Inc., hereafter known as the CIU, based in Bluefield, West Virginia, USA, agree to engage in the following mutually beneficial activities until both parties agree to dissolve the relationship:

With the assistance of the Coordinator of CIU Armenian Educational and Cultural Exchanges

1. Vanadzor School # 20 will invite CIU visiting professors to its campus for the delivery of lectures and workshops for agreed upon durations and time of year;
2. Prior to such visits, Vanadzor School # 20 will share with the CIU a list of relevant disciplines and topics for lectures and workshop so as to assist the CIU in recruiting appropriate and experienced visiting professors;
3. Prior to such visits, Vanadzor School # 20 will announce the forthcoming visit(s) to the VPC campus family so as to encourage attendance at the forthcoming series of lectures and workshops led by CIU visiting professors;
4. During the visit(s) to its campus by CIU visiting professors, Vanadzor School # 20 agrees to
 - a. arrange for Vanadzor School # 20 representatives to meet CIU Visiting professors upon arrival at Zvatsnots Airport in Yerevan and transfer them in a college vehicle to Vanadzor;
 - b. coordinate appropriate welcome and farewell activities for the visitors on the first and last day of their visit(s) to which appropriate stakeholders and Armenian and American officials might also be invited;
 - c. arrange for free boarding and lodging during the CIU visiting professors' stay in Vanadzor;
 - d. coordinate CIU visiting professors' transfers between lodgings and the Vanadzor School # 20 campus;
 - e. provide interpreting services for the efficient delivery of lectures and workshops led by CIU visiting professors;
 - f. provide an honorarium not to exceed 16 500 drams for each one-week visit for each CIU visiting professor at VPC;
 - g. arrange for Vanadzor School # 20 representatives and a college vehicle to transfer CIU visiting professors to a Yerevan hotel on the departure date stated in the schedule(s) and on the following day transfer them to Zvatsnots Airport, Yerevan.

Additional items considered necessary to further the efficacy of this activity may be determined in the future by both parties, the Vanadzor School # 20 and CIU. Such determinations will be mutually agreed to and signed by both parties, the Vanadzor School # 20 and the CIU, and will be added to this original document.

This agreement is entered into on August 01, 2007 by representatives of the Vanadzor School # 20 and the CIU whose signatures are indicated below.
